## Conception Working Group Questionnaire #1

As the Conception Working Group, we have been tasked to make a list of all the electronics on board at the time of the Conception fire.

Thanks in advance for your assistance. Be assured that we realize how painful this whole experience is for everyone involved, but especially loved ones. Your submissions are in confidence.

It would be very helpful if you could answer the following questions and provide the related media. As you assemble materials and find you need to narrow down what you submit, you will help us especially if you select those related particularly to our task: What electronics might have been on the Conception when fire broke out?

Our list will eventually include brand, models, and dates for: scuba lights, dive computers, dive (or other) cameras, battery recharging devices, surge protectors or extension cords, photography lights, cell phones, and PLBs (personal locator beacons), among other possibilities. In short, every electronic device imaginable.

We would ask that images be submitted in jpeg, png, or pdf format, and videos in **XXXXX format**. All responses, including media or text, can be submitted to: **whatever.CWG @ protonmail.com**.

1. Did your loved one have a nickname or preferred first or last name? This will be helpful as we search for information and compile our list.

2. Do you happen to be familiar with the brand, item, and/or model of any electronics your loved one might have had with them as they embarked on the Conception dive trip? If so, please list.
3. Are you aware if your loved one generally rented electronic equipment for dives? If so, what was the name of the shop, outfit, or group? Do you know which items?
4. Did your loved one have a favorite dive shop(s)? Would you mind providing the shop name and location?
5. Had your loved one taken commercial dive trips in the last 2 years? Do you happen to know when, where, or what company? Please list, if you can.
6. Did your loved one receive any scuba equipment gifts in the last 2 years for special occasions like birthdays, anniversaries, religious holidays? Would you mind describing them to the best of your knowledge?
7. Please provide several photos [the victim] took on dry land. We are particularly interested in the ones they may have taken with a phone. Content is not important in this category. If you have many, the most recent will be the most helpful. Format needed: electronic, not hard copy.
8. Please provide underwater photos either you know [the victim] took or are reasonably certain. If you need to choose, we are looking for photos of a lone underwater diver of the opposite sex taken on any occasion. If none, we can work with underwater landscapes or whatever you have. If you have many, the most recent would be the most helpful. Format needed: electronic, not hard copy.
9. If you know them, would you mind providing "handles" and the name of any scuba forum your loved one might have participated in?
10. Are you familiar with your loved one's social media accounts, e.g. Facebook, Twitter, Instagram, LinkedIn, Pinterest? If so, we'd like you to provide links to those accounts. Since we won't have "friend" status, we might need your help with access.
11. Did your loved one have friends they went diving with on a regular basis who might be familiar with their equipment or could supply photos? Are you able to

get in touch with them for permission to have us contact them via email? If so, could you please provide their name and email address?

12. Do we have your permission to contact you by phone or email if we need to follow up on the material we gather? What would be the best phone and email to reach you? Do you have preferred times?

The Conception Working Group's aim is to find the information your attorneys need to pursue your case, and we'd like to be effective. Feel free to comment or make suggestions on any question asked on this questionnaire.
