Sorry for the delay in getting back to you, I ended up down a number of rabbit holes that I wanted to take a minute to explore before getting back to you.

I found photos from our September 1999 trip aboard the conception but no photos of the inside I am afraid, I have attached the only ones worth while, others appeared to be mostly scenery.

I worked through what Ted had with him. I had thought for sure I remembered unmarked blue batteries with the charger he was packing but I have looked through a ton of different places for a receipt and I just can't for the life of me find anything. I am therefore thinking he just brought a few of our millions or rechargeable Nickel Metal Hydride AA batteries to go in his dive light. I have attached images with manufacturer info on the flashlight and charger. The batteries themselves still stump me a bit, but I think he would have known not to take lithium Ion batteries on the plane. This charger works with both which is why I am just not sure what he had for batteries but I can not find any records that would help me.

In addition to a dive light, batteries and charger Ted also would have had an iPhone (6S serial number 359159078609519) and an ipad (serial No DMPND0MAG5VT) and a black kindle with a black case. He would not have had any other electronic devices with him.

I have attached our 2019 and 2018 taxes (2019 is weird because he stopped working at the end of august but I did receive his back vacation pay). I am also attaching his W2's and any random 1099's from the last two years.

Thank you for helping us all with this, please let me know if you need anything else.
